Stage 2 of round 2 consultation for potential changes to AUC Rule 012: Noise Control

Background

The Alberta Utilities Commission (AUC or the Commission) is seeking feedback from stakeholders on potential changes to certain provisions of <u>Rule 012</u>: *Noise Control* to streamline and improve regulatory and adjudicative processes. To date, there have been two rounds of consultation.

Round 1 consultation

In <u>Bulletin 2022-08</u>, the Commission proposed changes to Rule 012 and requested written feedback on these changes. The consultation associated with Bulletin 2022-08 will be referred to as round 1 consultation.

The Commission has reviewed stakeholder feedback submitted in response to Bulletin 2022-08 and decided that it has received sufficient information on the changes proposed in Bulletin 2022-08. No further consultation is required regarding the changes specified in Bulletin 2022-08.

Round 2 consultation

Stage 1 of round 2 consultation

During round 1 consultation, several stakeholders identified matters for consideration in addition to the changes proposed in Bulletin 2022-08. These included the development of applicable permissible sound levels (PSLs) for receptors in urban areas and clarification on determination of PSLs for new dwellings.

The Commission issued <u>Bulletin 2022-12</u> and initiated another round of written consultation on potential Rule 012 revisions to address two topics: urban PSLs and new dwelling PSLs. The consultation associated with Bulletin 2022-12 will be referred to as stage 1 of round 2 consultation.

The Commission has reviewed stakeholder feedback submitted in response to Bulletin 2022-12. The Commission created a <u>comment matrix (Appendix A)</u> that summarizes the stakeholder feedback and provides Commission responses to the feedback.

Stage 2 of round 2 consultation

During stage 1 of round 2 consultation, the Commission has identified the following topics that require further consultation, which will be referred to as stage 2 of round 2 consultation:

- Determination of suburban and urban PSLs.
- Definition of suburban and urban receptors.
- Milestone for establishing PSLs at new dwellings.
- Tonality evaluation.

Discussion questions for stage 2 of round 2 consultation

In the <u>comment matrix (Appendix A)</u>, the Commission has included a number of questions to guide discussion. The Commission requests that stakeholder feedback be focused **exclusively** on the topics and associated questions specified in the comment matrix.
